LANESBOROUGH REIT COMPLETES \$7.9 MILLION SALE OF SASKATOON PROPERTY

Winnipeg, Manitoba, November 5, 2009 – Lanesborough Real Estate Investment Trust (“LREIT”) (TSX: LRT.UN) announced that it has completed the previously announced sale of a 100-suite townhouse property in Saskatoon, Saskatchewan, known as Village West Townhouses for \$7.9 Million. The sale resulted in net cash to LREIT of approximately \$2.99 Million, net of expenses and closing adjustments, and the repayment of approximately \$4.79 Million of first mortgage debt. LREIT will use the net cash from the sale to repay debt.
